REPORTS

- Tim working on lighting in gallery; may decide to keep what Curt had put in
- Curt unable to stay for 5pm meeting change; his report is to update board on Website Committee progress

UNFINISHED BUSINESS

- Sandi & Pat have Microsoft suite; Terri requests one also

NEW BUSINESS

- **2nd Saturday Art Classes** - Sandi requests explanations for class content
- **Summer in the Valley ad** update - ¼-page \$400; cost sharing to be decided
- **Student Scholarship** - no candidates; application deadline April 30; **(1) Angie proposes we continue to rollover the funds, (2) Sandi seconded; all agree.**
- **SAG/3rdStreet Brochure** - Angie says it goes out tomorrow bulk rate with mail labels; \$186 (\$200 budgeted in Calendar Show); \$360 brochure cost
- **Membership Meeting** (reach, format and design)– Angie & Don will start plan in May; Terri projects July date
- **Budget Revisions** /update- Angie to meet w Liz, Terri & Pat to tweak; if any extreme any changes, will go to BOD vote
- **Update regarding SAG website** - Don, Curt, Sandi, Angie
- **DOMAINS NEED AMENDING: Curt says domain status is as follows: Have: sangresartguild.org; Has Renewed: artshullabaloo.org; allaprimawestcliffe.org; To Be Renewed: sagarts.art. —***(1)Terri proposes we allow 5 domains to expire & keep 2 (SAG Arts.org & Hullabaloo.org); (2) Angie seconds; all agree.**
- Curt will not build the new website. Curt & Linnea have offered 2 suggestions for people who might help. Sandi says it's not really about *design*, but more about *conversion* to Wild Apricot. Don says Wild Apricot has templates; the Committee agrees about hierarchy. Don mentions he could do "updates" but not the *building* - it's too much. Best resource may be Wild Apricot for advice about basic structure. Tim suggests exploring talent & interest among members.
- Issues are **cost & appropriately skilled tech consultant(s).**
- Sandi says we don't now have access to files & she thinks there should be a way to *call files over* rather than making the transfer unnecessarily labor intensive. Curt found that it's more difficult than initially thought. The **Committee will meet with Curt to discuss again soon.**
